- Nominees from the floor were asked for. No nominees.
- Voting was opened

Guest Speakers:

- Al Mauldin of Mauldin's Well Service. 360-378-0975
 - Al gave a brief history of his work experience which began working with Denny Martel.
 - Explained the rules for residential wells; less than 5,000 gallons/day or 3 gallons/minute. Anything more than that requires a thorough study via the state of Washington
 - Allowed to irrigate ¼ acre/day.
 - Discussed the soil composition of the different islands.
 - Discussed varying levels that occur in drilling wells. The average being 300-400 feet before the drought of the 1990's. During that time, he was drilling wells at 600 feet and some as deep as 900 feet.
 - Typically, the well is a 6-inch diameter hole.
 - Discussed static measuring- important to do regularly.
 - Discussed bacteria testing through Edge. Again, important to do regularly.
 - Discussed codes for placement of wells in relation to septic fields and property lines.
- Laura Jo Severson, on behalf of Firewise:
 - Discussed need for an exit plan in case of fire.
 - Discussed need for an alert system.
 - Discussed care that must be taken when operating power tools/lawn tools.
 - Discussed plan to host a separate Firewise meeting.
